Explanations of Basic Grading Components

Individual Exams

- \checkmark There will be three regular exams (100 pts each) and one final exam (200 pts).
- Exams will be completed online, through Canvas, utilizing Respondus Lockdown. A webcam is REQUIRED to open and complete all exams. If you do not have and cannot afford a webcam, visit with Dr. Reiling (they are relatively inexpensive). You will also need your photo ID. Finally, a quiet place to take the exam with a strong internet connection is highly recommended.
- ✓ Exams may be taken only ONCE with a <u>maximum of 1 hour to complete the exam</u> (2 hrs for final).
- Exams will come available by 12:00 pm on Monday (see schedule) and are DUE to be completed by 11:59 pm on Wednesday (see schedule). If you miss the completion due date/time, exams are available for two additional days, but a 10% late penalty (per day) will be assessed.
- ✓ Barring significant extenuating circumstances, a zero will be assigned to all exams not completed by 11:59 pm, Friday after release (see schedule).
- ✓ Most exam questions will be multiple-choice, but not necessarily all.
- Examination material may be pulled from any provided resource including recorded lectures, in-class discussions, and other materials provided in-class or via Canvas (i.e., glossaries of terms, other resources, video clips, etc.). Even if material is not specifically addressed during class, if provided, the material is "fair game" for testing purposes. For example, we may not discuss or use all terms provided as part of the glossaries, but you should still know those terms as a student of Animal Science.
- Questions will appear one at a time, and you must answer each question before moving forward.
- The final exam will have 100 pts devoted to "new" material, and 100 pts cumulative (i.e., associated with material related to what was addressed with the 1st 3 exams). The cumulative portion will address the same material as previously tested but not necessarily the same questions.
- ✓ Grading appeals. If you answered a question wrong but believe your answer is justified, you may submit a <u>written appeal</u> (via email) detailing why you should be given credit for the answer. You must provide evidence supporting your answer and outline an associated convincing argument for the case. You have 1 week, after scheduled exam due date to submit your appeal. Thereafter, all scores are final.

Online Quizzes

- ✓ There will be 9 online guizzes; each guiz will be worth 25 points
- ✓ Each quiz may be taken up to three times; and your high score will be recorded.
- ✓ Quizzes are open-note, and unproctored, but you will only have 20 minutes to complete the guiz.
- Quizzes are ONLY available for a specified period and should be taken by the assigned due date.
- ✓ A 10% late penalty (per day) will be assessed for all guizzes completed after the assigned due date.
- ✓ Quizzes go off-line (no longer available) at 11:59 pm on Friday after release. Zeros will be assigned to all quizzes not completed by this time.
- ✓ Quizzes will be conducted through Canvas.
- ✓ All material provided in-class or through Canvas related to the guiz topic is "fair game".
- ✓ Questions will appear one at a time, and you must answer each question before moving forward.
- ✓ Because we all have busy lives, and it's slightly possible ⊕ that you might forget to complete a quiz, or not do as well as desired, your LOW quiz score will be dropped from the grade calculation. Thus, your top 8 quiz scores will be used: total possible points = 200.

Daily Participation Points

- ✓ Active learning quiz questions &/or opinion polls will be administered during lecture, nearly every day.
- ✓ When administered, Daily "quizzes" &/or opinion polls will be worth up to 5 pts.
 - > Participation (even if you answer everything wrong) will be worth at least 1 point/day.
 - > Performance (answering <u>review questions</u> correctly) will be worth 1-4 points/day.
- ✓ Although there are 44 class meetings during the semester, on occasion, it may not be possible to administer a subsequent learning activity, other than lecture. However, you can be assured that

minimally, 200 points will be available (that's 40 of 44 class meetings).

- > Will you earn all 5 points each day; probably not, but we're dropping one-third of the points.
- With regular attendance (in class or via zoom), there is no reason that you should not accumulate all 120 points that will contribute to your overall grade.
- > Because we only count 120/200 possible points, there will be NO MAKEUPS.
- > Points earned more than 120 may contribute to extra credit (see explanation on extra credit).

Extra Credit -

- ✓ A maximum of 20 extra credit points (2.4% of total points) may be earned throughout the semester.
- ✓ These extra credit points will be added to the student's total; not to the class total.
- ✓ How can I earn these extra credit points?
 - > Extra Daily Points.
 - For every 20 additional points accumulated above 100 (the points that contribute directly towards grade determination), you will earn 2 extra credit points, up to a maximum of 8 extra credit points per the following scale:
 - 140-159 daily pts = 2 EC pts,
 - 160-179 daily pts = 4 EC pts,
 - 180-199 daily pts = 6 EC pts,
 - 200+ daily pts = 8 EC pts
 - For seminars that have an Animal Science or agricultural connection, you may earn up to 5 pts extra credit for your attendance and reflection. A reflection paper does not simply reiterate the seminar. Rather, I want you to provide your reflection -- your thoughts. Did you agree/disagree, why or why not? If the speaker provided suggestions, were they feasible. What do you think should be done? How might this issue affect your future livelihood? Etc., Etc. For credit, reflection reports (1 page, 1-inch margins, 12-pt Times New Roman font, single spaced) must be turned in by the end of the week following the seminar. ONLY hard copy reports, turned in before or after class will be accepted for potential extra credit.

Instructional Continuity Plans: If in-person classes are cancelled by the University, you will be notified of the instructional continuity plan for this class with an announcement posted to Canvas. It is recommended that Canvas be set-up to automatically forward announcements to you, via email or text.

Grading Appeals: A student who feels that he/she has been unfairly graded must ordinarily take the following sequential steps in a timely manner, usually by initiating the appeal within the first 3 weeks of the semester following the awarding of the grade:

- 1) Student should schedule a meeting with the course instructor to discuss the issue. Most concerns are resolved at this point.
- 2) If student is not satisfied with results of the instructor meeting, a written appeal may be submitted to the ASCI Undergraduate Coordinator who will then forward that appeal to the Animal Science Undergraduate Curriculum Committee. The committee decision will be forwarded, in writing or via email, to the student by the ASCI Undergraduate Coordinator with instructor copied.
- 3) If student is not satisfied with the committee decision, he/she may meet with the instructor's unit administrator

- (ASCI Department Head) to discuss the situation.
- 4) If the concern is not resolved at the departmental level, the final step is to submit a grade appeal to the CASNR Dean by contacting the Dean's Office, 103 Agriculture Hall. Notification to the Dean must be in writing and will include in the notice a statement of the grounds of appeal. Both the student and the instructor will be given an opportunity to present materials to the Dean in the presence of each other.

Photography and Videography in Areas with Animals: Contact between visitors (including students) to the University and animals used in research and teaching can constitute both a positive learning experience for the visitors, and a health risk to the animals and visitors. The following policy is intended to ensure a minimally disruptive environment to resident animals, to protect the health of research and teaching animals, to protect confidentiality and integrity of research, and to help in the accurate representation of the University's policies and procedures.

- 1) <u>Use of recording devices</u> such as cameras, video recorders, tape recorders, camera phones, etc. in a secured animal facility <u>must receive prior approval</u> from the Department Head, IACP Attending and/or Clinical Veterinarian, or the IACUC Compliance Coordinator, with the following exceptions.
 - a. When performed by authorized PI or designee when required for scientific or publicity reasons, when due consideration is given to ensuring that the University of Nebraska is accurately represented.
 - b. When performed by authorized personnel when required to assist in clinical diagnosis of disease.
 - c. When performed by authorized personnel when required to document compliance or animal handling issues at the direction of University officials, IACUCs, veterinarians, and representatives of federal agencies
- 2) This requirement is waived for government inspectors, and other visitors present at the request or as a requirement of the University (e.g., AAALAC site visitors, IACUC members, Laboratory Animal Veterinarians).
- All approved recording procedures have been documented in the Animal Use Protocol on file for this course.
- 4) All visitors must abide by individual facility Standard Operating Procedures pertaining to protective clothing, TB testing, etc. If protective clothing is required for any particular activity conducted within this course, students will be notified of such needs (i.e., hard-soled shoes, etc.), or such protective gear will be provided (i.e., frocks and hard hats in the meat lab, etc.).
- 5) Every effort should be made to show appropriate and accurate context when audio or visual recordings are made (i.e., if an animal is anesthetized or sedated, include the vaporizer or tray holding the bottle of injectable drug).
- 6) The IACUC <u>reserves the right to review</u> any and all pictures and video recordings, tape recordings, or camera (film or digital) images before release, and may require that these images/recordings be destroyed.

If a satisfactory solution is still not achieved at the departmental level, the student may then appeal through the CASNR Dean's Office and the University Director of Student Judicial Affairs, in that order and subject to the processes and requirements of those offices.

- 1) Fire Alarm (or other evacuation): In the event of a fire alarm, gather belongings (purse, keys, cellphone, N-card, etc.), and use the nearest exit to leave the building. Do not use the elevators. After exiting, notify emergency personnel of the location of persons unable to exit the building. Do not return to the building, unless told to do so by emergency personnel.
- 2) Tornado Warning: When sirens sound, move to the lowest interior area of the building or designated shelter. Stay

away from windows and stay near an inside wall when possible.

- 3) Active Shooter:
 - a. Evacuate If there is a safe escape path, leave belongings behind, keep hands visible and follow police officer instructions
 - **b. Hide out** If evaluation is impossible, secure yourself in your space by turning out lights, closing blinds, and barricading doors, if possible.
 - c. Take action As a last resort, and only when your life in in imminent danger, attempt to disrupt and/or incapacitate the active shooter.
